

Anti Social Behaviour Policy

1.0 Statement of Intent

- 1.1 Orwell Housing Association is committed to the elimination of all forms of anti-social behaviour (ASB) in the areas in which we work.
- 1.2 Orwell considers that its all tenants and service users have a right to the peaceful enjoyment of their home and communities free from threats, risk or intimidation.
- 1.3 Orwell will not condone or tolerate any form of ASB from its tenants, employees or from agents acting on behalf of us.
- **2.0** 'anti-social behaviour' means (ASB and policing Act 2014)
- 2.1 conduct that has caused, or is likely to cause, harassment, alarm or distress to any person,
- 2.2 conduct capable of causing nuisance or annoyance to a person in relation to that person's occupation of residential premises, or
- 2.3 conduct capable of causing housing-related nuisance or annoyance to any person.' Housing-related' means directly or indirectly relating to the housing management functions of Orwell.
- 3.0 'harassment' means (Equality Act 2010 harassment)
- 3.1 unwanted conduct related to a relevant protected characteristic, which has the purpose or effect of violating an individual's dignity or creating and intimidating, hostile, degrading, humiliating or offensive environment for that individual.
- **4.0** 'hate crime means' (ASB and policing Act 2014)
- 4.1 Hate crimes are any crimes that are perceived to be targeted at a person because of hostility or prejudice towards that person's disability race or ethnicity, religion or belief, sexual orientation or transgender identity

5.0 We will

- 5.1 recognise that left unchallenged, anti-social behaviour can have a significant negative impact on the lives of our residents.
- 5.2 make use of the powers, orders and mechanisms available to us to deal with anti-social behaviour.
- 5.3 participate in joint working with partner agencies.

- 5.4 place victims and witnesses at the centre of our procedures.
- 5.5 act quickly to investigate and act upon all reported cases. We will use all appropriate measures including those provided by law and those recommended as good practice.
- **6.0** By the use of these methods we'll deliver a proportionate and flexible response to anti-social behaviour. We shall endeavour to prevent ASB occurring by:-
- 6.1 offering or facilitating support to tenants at risk of breaking their tenancy through ASB,
- 6.2 providing environments that minimise opportunity for committing ASB and promote a sense of community
- 6.3 supporting complainants, victims and potential witnesses and ensure we gather and respond to feedback about our approach.
